### **Definitions**

- 1 "Number of Students Who Began Program" means the number of students who began the program who are scheduled to complete the program within the reporting calendar year.
- 2 "Students Available for Graduation" refers to the number of students had accumulated the number of units to graduate within the reporting year. Programs have variable unit requirement, between 48 and 72.
- 3 "Number of Graduates" is the number of students who have completed the program.
- 4 "Completion Rate" is the number of Graduates divided by the Number of Students Available for Graduation.
- 5 "Graduates available for employment" means the number of graduates minus the number of graduates unavailable for employment. Graduates unavailable for employment means graduates who, after graduation, die, become incarcerated, are called to active military duty, are international students that leave the United States or do not have a visa allowing employment in the United States, or are continuing their education in an accredited or bureau-approved postsecondary institution.
- 6 "Graduates employed in the field" means graduates who are gainfully employed within six months of graduation in a position for which the skills obtained through the education and training provided by the institution are required or provided a significant advantage to the graduate in obtaining the position.
- 7 Salary is as reported by the student. Not all graduates reported salary.
